

Information for the processing of personal data for the registration at the contest organised by the National Supervisory Authority for Personal Data Processing with the occasion of 3 years of GDPR

The purpose of the processing

We use your personal data solely for the following **purpose**:

- The registration and participation at the online essays contest addressed to the students, having as subject "The Protection of personal data within the educational system in the context of the Covid-19 pandemic".

The legal basis of the processing

The processing of the personal data will be performed in accordance with Article 6 letter a) of Regulation (EU) 2016/679 "the data subject has given consent to the processing of his or her personal data for one or more specific purposes" and Article 7 of Regulation (EU) 2016/679.

Therefore, the participant-student shall send the essay from his/her e-mail address together with his/her consent. Within the message transmitted via electronic e-mail also the contact phone number shall be mentioned in order to confirm the participation at the contest.

What personal data does the National Supervisory Authority for Personal Data Processing process?

For the registration and participation at the contest, the National Supervisory Authority for Personal Data Processing will process the following personal data of the participant-student:

First name and last name, e-mail address, phone number (only for the winner)

In order to participate to the contest, it is necessary to establish the capacity of student. In this respect, the participant shall proof that he/she is a student by providing a relevant document issued by the higher education institution to which he/she is enrolled (for example, copy of the student pass stamped for the current academic year by blurring the personal data, except for the first name and last name; document issued by the higher education institution from which it results that the participant is enrolled at the courses organised by that higher education institution, by blurring the personal data except for the first name and last name).

Who are the data subjects?

The data subjects whose personal data will be processed by the National Supervisory Authority for Personal Data Processing, exclusively for the registration and participation at the contest are **you**.

Who are the recipients of your personal data?

The confidentiality of the personal data will be ensured by the National Supervisory Authority for Data Protection Processing and the personal data will not be disclosed to other recipients.

The duration of the personal data processing

For the fulfilment of the above mentioned purpose, the National Supervisory Authority for Personal Data Processing will process the personal data of the data subjects from the moment of collecting until the date of 2nd of July 2021 (a week after the date of designation of the winner by ANSPDCP). Subsequent to the termination of the personal data processing operations (the designation of the winner) for the fulfilment the purpose for which they were collected, these data will be erased.

What are your rights?

According to the provisions of **Regulation (EU) 2016/679**, you benefit from **the right of access, the right to rectification, the right to erasure of data, right to restriction of the processing, right to data portability, right to object, as well as the right to submit a complaint to the national supervisory authority.**

You can withdraw your consent regarding the processing, in any moment, without for its withdrawal to affect the lawfulness of the processing performed before the withdrawal of the consent.
